Ph.D. Admission Notice

Online applications are invited for the admission for "Ph.D. Degree in Ayurveda, Ayurvedic Pharmaceutical Science & Medicinal Plant Science" from Institute for Post Graduate Teaching & Research in Ayurveda, Gujarat Ayurved University, Jamnagar. Application form will be available online from **05.10.2018** on the website www.ayurveduniversity.edu.in and application form can be filled online up to **20.10.2018** at 05.00 p.m.. Application fee is of Rs. 2000/- for General Category / SEBC / OBC and for SC/ST Rs. 1500/- and payment is to be made online only. Admission in Ph.D. course will be done on the basis of the merit of mandatory written examination of 100 marks separately for the **Ph.D. Degree in Ayurveda, Ayurvedic Pharmaceutical Science & Medicinal Plant Science** Admission test will be conducted on **29.10.2018**, and **counseling is likely to be held on 30.10.2018 onwards**. Candidates may plan their travel accordingly. Other details are available on our website. Scholars appearing in their Post Graduation Final Year Examination can also apply, however their admission will be subject to the result of final examination declared before the date of counseling.

Candidate will be required to submit self attested copies of S.S.C., B.A.M.S. / B. Pharm, M. Sc. Medicinal Plant, M. Pharm / M.D./ M.S. (Ayu). at the time of counseling.

50% seats out of total seats will be reservation for the students passed their graduation (Bachelor degree) from Gujarat Ayurved University and remaining 50% seats will be reserve for the students passed their bachelor degree from other than Gujarat Ayurved University in each specialty.

Among these, Group reservation for SC, ST and OBC / SEBC and PH will be maintained as per state Government and Central Government roster points for Gujarat Ayurved University graduate & out of the Gujarat Ayurved University graduate respectively.

If quota of any category remains vacant, it should be filled with subsequent other category as per the merit and availability of seats under guide. The total reservation should not exceed more than 50%.

The candidate already in service will be required to submit NOC at the time of counseling along with written assurance that if selected, the employer will relieve them for the period of at least 2 years because as per rules the Ph.D. candidates have to stay in the Institute at Jamnagar for 2 years and no relaxation in this regard is permissible.

Total 20 stipendiary seats for Ph.D. Degree in Ayurveda at I.P.G.T. & R.A. are available for the candidates and stipend will be paid as per the rules of Govt. of India. Details regarding the availability of Guides, procedure of admission and Ph.D. regulation (Approved by 28th PG Board dated 28.08.2018) is also available on the Website of the University. All are hereby instructed to refer the same carefully before proceeding further.

If two candidates of the same category get equal marks in entrance test, their total marks of final year BAMS theory exam will be considered for merit place. In case where the total of final year BAMS marks are also found equal, total marks of the 12th standard will be considered to decide merit.
