



24/12/2016	10.00 A.M.	PGT Institute Building, Third Floor, Gujarat Ayurved University, Hospital Road, Jamnagar – 361008.

Candidate should be present at the above test centre at 08.00 A.M. on date 24/12/2016 without fail for verification of documents and followed by written test.

In the written test OMR based multiple choice questions based on 80% Subject related and 20% General Knowledge will be asked.

Based on written qualifying test, first six candidates will be call for personal interview on 27/12/2016 at 03.00 P.M. The result of the written qualifying test will be declared on University website www.ayurveduniversity.edu.in. Eligible candidate for personal interview will be informed by Phone / Email only. Mark of written test will not be carry forward for the personal interview.

The qualified candidate is expected to bring all the original documents such as Marksheets, Degree Certificates, testimonials, Caste Certificate and Birthday Certificate. "No objection Certificate" from present employer is also required to be produced in Original at the time of Personal Interview.

No TA / DA will be paid for written examination.

- [1] Candidate remain present with any valid photo id (election card / pancard / driving license etc.) for your personal identification, failing to which you will not be allowed to appear for written test. Please submit Xerox copy of your id-card to exam supervisor.
- [2] Please note that no candidate will be allow to appear for written test if(s) he reports any time after 09.30 a.m. on 24/12/2016.
- [3] Only Black or Blue ball point pen is to be used for answering all questions.
- [4] Only first six candidates will be called for personal interview on the basis of merit of written qualifying test.
- [5] There is no negative marking.
- [6] Any request regarding re-assessment or re-checking of answer sheet will not be taken into consideration.
- [7] Assistant or scribe will not be granted.
- [8] Candidate should attend the written test at his /her own cost.
- [9] The answer sheet will not be entertained / considered due to wrongly written in Roll No / Question Booklet Series / Question Booklet No. by the candidate.
- [10] The candidate has to mark carefully in OMR sheet. If any mistake to put more than one marking in OMR sheet that will be considered ambiguous and treated as wrong answer.
