

- 3. In case of Joint participation, maximum two participants will be allowed.
- 4. Participants can submit maximum two logo designs.
- 5. The entry form for the competition should be duly filled by the participants and submitted along with the logo design. The entry form for the competition can be collected from the student table of institute or can be downloaded from the university website. (Annexure-1)
- 6. The logo design must be submitted in **soft copy as well as colour hard copy**.
