PREAMBLE:-

As on now, the Ayurvedic Pharmacist (Pharmacy) Act has not been enacted by the State Government. Therefore in absence of registration of Ayurvedic Pharmacist (Diploma/Degree/Post Graduate), the qualified candidates were not able to get jobs in their field. Hence an approval in principle is accorded by the State Government to the Gujarat Board of Ayurvedic and Unani Systems of Medicine, Gujarat State, as an interim (stop gap) arrangement until the State Government come out with the enactment of Ayurvedic Pharmacist Act to keep a separate register for Registration of Diploma/Degree/Post Graduate in Ayurvedic Pharmacist. Thus, the issue of Registration of Ayurvedic Pharmacist (Diploma/Degree/Post Graduate) was under consideration of the State Government:-

RESOLUTION:-

After due and careful consideration, the State Government has resolved the following procedure/scheme for the registration of Ayurvedic Pharmacist(Diploma/Degree/Post Graduate) would be implemented by Board of Ayurvedic and Unani System of Medicine, Gujarat State, Ahmedabad henceforth as follows:-

1. AIMS & OBJECTS :

The following scheme for the registration of Ayurvedic Pharmacist is introduced with a view to produce competent Pharmacy Assistants/Compounders of a uniform standard for Ayurvedic Pharmacies / Institutions

and Hospitals. The candidates shall be able to work efficiently as Compounders, Pharmacist and discharge other duties in the Hospital, dispensaries of pharmacies.


2. REGISTRATION :

1. A candidate who has undergone the prescribed courses/studies and training, and has passed the final examination from the recognized institution shall be eligible for registration by the Gujarat Board of Ayurvedic & Unani Systems of Medicine, Gujarat State in the register of Ayurvedic Pharmacist . Only registered Ayurvedic Pharmacist shall be given services in Governments and other aided Ayurvedic hospitals, dispensaries, pharmacies and other institutions. The registered pharmacist may also setup a shop for the purpose of stock and sale of Ayurvedic medicines.
2. No person shall be entitled under this section to have his name entered in the register if he/she is minor.
3. Gujarat Board of Ayurvedic & Unani Systems of Medicine shall maintain a register of qualified Ayurvedic Pharmacists ~~in~~ separately.
4. Every candidate who has obtained the Diploma, Degree, Post Graduate Certificate in Pharmacy(Ayurvedic) from recognized institution shall, on payment of fee Rs. 1500/- be entitled to have his name enrolled in the above register.
5. Every candidate who desires to have his/her name enrolled on the aforesaid Register, shall apply to the Registrar, Gujarat Board of Ayurvedic & Unani Systems of Medicine, Gujarat State, in the prescribed form along with two recent passport size photograph together with registration fee giving full particulars of information required in the application form. He /She shall submit along with his/her application and

attested copy of the diploma, degree, Post Graduate certificate obtained by him from the recognized institutions.

6. Every candidate registered under this scheme shall receive from the Registrar Gujarat Board of Ayurvedic & Unani Systems of Medicine, Gujarat State a certificate of enrolment in the prescribed form.
7. After the preparation of the list the board may decide a date, and every two years there after the registration of the register Ayurvedic pharmacist shall be renewed on payment of Rs.800/-. If the renewal fee be paid on or before the due date, the Registrar shall issue to the registered Ayurvedic pharmacist a renewal slip in the prescribed form specifying the date up to which the validity of the certificate of registration has been extended.
8. If the renewal fee has not been paid by the due date, the Registrar shall remove the name of the Ayurvedic pharmacist from the register entered under the scheme, and the name so removed may be re-entered in the register on payment of the outstanding renewal fees, and on receipt of additional fees of Rs 500/- by the registered Ayurvedic pharmacist, the Registrar shall issue a renewal slip.
9. The Registrar and the staff will be paid a fix honorarium decided by the board time to time for carrying out the duty under this scheme.
