Service Conduct Rules

- (a) Each staff for the SFI's will be on contract base for one year. The contract may be renewed. He / She may be extended for another term after proper assessment by committee (Framed by the Governing Body)
- (b) Principal will be the academic head and administrative officer will be administrative head.
- (c) (1) No Employee of SFI's shall under take any out side work remunerative or otherwise, without the previous sanction of the concerned head.
- (2) An employee shall not publish or cause to be published any statement of fact or information which may embarrass the Institutional authority.
- (3) I No employee shall become a member of any political party or organization that has been declared unconstitutional by the Government.
- II No employee shall contest any election of Parliament, Legislative, District Panchayats, Municipalities or such other bodies while in service.
- III No employee shall resign his / her post without giving one month's notice or notice pay.
- IV The competent authority may, however, relieve the employee earlier.
- V If authority has satisfactory reason regarding misconduct or in disciplinary behaviour of employee competent authority can relieve the employee before expiry of contract.
- VI No employee shall prosecute studies or appear in any examination without obtaining prior permission of competent authority.

• LEAVES

As the contract base staff is not eligible to get any other leave therefore the staff may be given 20 days leave of absence in a full calendar year with the benefit of prefix & suffix holidays.

• RECRUITMENT RULES

- [a] For the B.A.M.S. course recruitment rules for the teaching staff will be as prescribed by Statute - 193 - A of Gujarat Ayurved University.
- ✓ For other institute persons having a graduate degree with the related subject or field will be eligible for the post of lecturer for certificate or diploma courses.
- ✓ For the post of Lecturer in degree course post graduate degree in the concerned subject will be essential.

For the post graduate course doctorate degree with the master degree in concerned subject will desirable or having a five years teaching experience in the concerned subject at graduate level will be essential.

- (1) Master's degree with 5 years experience or Bachelor's degree having at least IInd class with 7 years experience in a responsible administrative academic position.
